# EBAY NOVA DEVELOPER AWARD OFFICIAL RULES

NO PURCHASE NECESSARY. THIS IS A CONTEST OF SKILL; CHANCE PLAYS NO PART IN THE DETERMINATION OF PRIZE WINNERS.

OPEN TO LEGAL RESIDENTS OF: (a) THE FIFTY (50) UNITED STATES AND THE DISTRICT OF COLUMBIA WHO ARE 18 YEARS OF AGE AND OLDER, WHO ARE PHYSICALLY LOCATED AND RESIDE IN THE UNITED STATES OR DISTRICT OF COLUMBIA; OR (b) CANADA (EXCEPT THE PROVINCE OF QUEBEC) WHO ARE OF THE AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE, WHO ARE PHYSICALLY LOCATED AND RESIDE IN CANADA; OR (c) GERMANY WHO ARE THE AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE, WHO ARE PHYSICALLY LOCATED AND RESIDE IN GERMANY; OR (d) FRANCE WHO ARE THE AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE, WHO ARE PHYSICALLY LOCATED AND RESIDE IN FRANCE; OR (e) ITALY WHO ARE THE AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE, WHO ARE PHYSICALLY LOCATED AND RESIDE IN ITALY; OR (f) SPAIN WHO ARE THE AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE, WHO ARE PHYSICALLY LOCATED AND RESIDE IN SPAIN; OR (q) AUSTRALIA WHO ARE THE AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE, WHO ARE PHYSICALLY LOCATED AND RESIDE IN AUSTRALIA; OR (h) HONG KONG WHO ARE THE AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE, WHO ARE PHYSICALLY LOCATED AND RESIDE IN HONG KONG; OR (i) THE PEOPLE'S REPUBLIC OF CHINA WHO ARE THE AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE, WHO ARE PHYSICALLY LOCATED AND RESIDE IN THE PEOPLE'S REPUBLIC OF CHINA; WHO ARE MEMBERS OF THE EBAY DEVELOPER COMMUNITY WITH AN ACTIVE AND VALID EBAY DEVELOPER ACCOUNT.

VOID IN PUERTO RICO, THE PROVINCE OF QUEBEC AND WHERE PROHIBITED.

1. ELIGIBILITY: eBay Nova Developer Award (the "Award") is a contest of skill and is open to legal residents of: (a) the fifty (50) United States and the District of Columbia, who are 18 years of age and older, who are physically located and reside in the United States or District of Columbia; or (b) Canada (except the Province of Quebec) who are of the age of majority in their jurisdiction of residence, who are physically located and reside in Canada; or (c) Germany who are the age of majority in their jurisdiction of residence, who are physically located and reside in Germany; or (d) France who are the age of majority in their jurisdiction of residence, who are physically located and reside in France; or (e) Italy who are the age of majority in their jurisdiction of residence, who are physically located and reside in Italy; or (f) Spain who are the age of majority in their jurisdiction of residence, who are physically

located and reside in Spain; or (g) Australia who are the age of majority in their jurisdiction of residence, who are physically located and reside in Australia; or (h) Hong Kong who are the age of majority in their jurisdiction of residence, who are physically located and reside in Hong Kong; or (i) the People's Republic of China who are the age of majority in their jurisdiction of residence, who are physically located and reside in the People's Republic of China; who are members of the eBay Developer community with an active and valid eBay Developer Account as of the time of the submission and at the end of the Award (each referred to in these rules as an "Eligible Participant", "entrant", "you"). An "active account" in this sense requires an active application which uses eBay's Application Program Interfaces (APIs). Participation in the eBay Nova Award requires active participation of each Eligible Participant. Participation in the eBay Nova Award is free of charge. Eligible Participants may only participate once, even if they have multiple developer accounts. An Eligible Participant, for purposes of this Award, is defined as one (1) person. Only one (1) person will be eligible to win a prize. Void in Puerto Rico, the province of Quebec and where prohibited. Employees, directors and officers, and their immediate families (spouse, parents, children, siblings, and their respective spouses), and their respective household members (whether related or not), of eBay Inc. ("eBay") and its affiliates, subsidiaries, and divisions ("eBay Entities") (eBay and eBay Entities collectively, "Sponsor"), Sponsor's advertising and promotion agencies, and Wire Stone, part of Accenture Interactive, and all others associated with the design, execution, production, development, and promotion of this Award or are connected to this Award in any way are not eligible to enter. Award is subject to all applicable federal, state, and local laws. US law governs this Award and personal jurisdiction shall exclusively be the state and federal courts located in Santa Clara, California.

- 2. AWARD TIMING: The Award begins at 12:00:00 AM Pacific Time (PT) on November 27, 2018 and ends 11:59:59 PM PT on May 31, 2019 (the "Award Period"). Up to three (3) winners will be determined and will receive an eBay Nova Award at the end of the Award Period from among all eligible entries received. Entrants are responsible for determining the corresponding time zone in their respective jurisdictions.
- 3. HOW TO ENTER: To enter the Award, go to <u>https://developer.ebay.com/nova</u> (the "Website") and click the Apply Now button to open the online entry form (you will be required to sign in with your developer account username and password). Complete the following steps during the Award Period:

(1) Complete all the information on the online entry form;

(2) As a Developer, describe your innovative application of eBay APIs that has the potential to positively impact business and explain why it should be selected for an eBay Nova Award. Communicate the following details in your response:

- Do you buy and/or sell on eBay?
- How long have you been developing apps for eBay?
- What is the nature and function of the application you are submitting for review?
- In what matter is the application considered innovative?
- How does the application use the APIs in an innovative fashion?
- What is the business impact of the application?

(3) Once you have completed the above steps, you may submit your Entry.

Entry must be received no later than 11:59:59 PM PT on May 31, 2019 in order to be eligible.

All components of each Entry must be submitted online in accordance with these Official Rules and received by 11:59:59 PM PT on May 31, 2019 in order to be eligible. Incomplete Entries or Entries not complying with these Official Rules are subject to disqualification. Entries that have been generated by a script, macro, bot or any other automated means will be deemed void. Sponsor is not responsible for late, lost, incomplete, illegible, damaged, or misdirected Entries. Sponsor's decisions are final on all matters relating to this Award. If a dispute results as to the identity of an online entrant, it will be determined that the online entry was submitted by the authorized account holder of the eBay developer ID from which the entry is made. For these purposes, the authorized account holder is the natural person assigned to an eBay developer ID by eBay Inc.

- 4. JUDGING PERIOD: During the Judging Period, which will run from 12:00:00 AM PT on June 3, 2019 through 11:59:59 PM PT on June 21, 2019, all eligible entries will be judged by a panel of expert judges based on the following criteria: (i) Originality/Innovation 20%; (ii) Design and Presentation– 20%; (iii) Technical Quality– 20%; (iv) Embodiment of eBay's core values 20%; (v) The degree to which the application of eBay APIs developed and submitted by the entrant has the potential to positively impact a business's success 20%. Judging will be performed by a panel of judges selected by the Sponsor in its sole discretion. Up to a maximum of three (3) top-scoring entries, as determined by Sponsor, will be declared potential winners, subject to validation and verification of eligibility and compliance with all terms and conditions set forth in these Official Rules. In the event of a tie, the Entries involved in the tie will be reviewed by an additional judge who will serve as a tiebreaker and who will evaluate Entries according to the criteria listed above.
